3-501.16	Observed fish and ribs being held on the hot hold table at 114F-115F degrees. All potentially hazardous food being hot held must maintain a temperature of at least 135F degrees. Readjust the hot hold table so that food temperatures of PHF are at 135F degrees or above.	02/11/2008
3-501.16	Observed cold salad items at the salad bar such as the pasta salad that are at temperatures of 50F-51F degrees. All potentially hazardous foods that are being cold held must be at a temperature of at least 41F degrees. Adjust the temperature in the cold hold salad bar (add more ice) so that the temperature of PHF foods at the salad bar are maintained at 41F degrees or below.	02/11/2008
3-306.11	Observed open cookies underneath the dome shaped container available for self serve. The dome is not adequate protection for self serve foods because it can be completely opened. Prewrap the cookies before placing them underneath the dome container to prevent accidental contamination to the cookies. The self serve popcorn unit does not provide enough adequate food protection for customer self serve. Remove the unit from self service or prebag/prepack the popcorn. Customers are not allowed to self serve themselves.	02/25/2008
