6-501.114	FRP boards for the mop sink area is not installed. No mop rack is installed. Per prior inspection on 4/23/2007, corporate office was contacted to install the FRP board and the mop rack. Install FRP board on the mop sink area wall so that the walls are smooth and easily cleanable. Install mop racks so mops can be hung to facilitate drying.		07/13/2007

Notes: Dump out all dirty water from the mop bucket when done using. Instruct employees to regularly walk the cooler aisle and discard any expired milk or egg products. Mark expired products to prevent customer purchase.
