No paper towels at the warewashing handsink.

4 compartment sinks now have hot and cold water but the prewash and the wash compartments are full of rust. When water is run, the sinks back up and do not drain. Repair plumbing or try cleaning out the grease trap. Suspension of processing until sinks are repaired. See suspension order.
