8-301.11	The men and women's restrooms were littered with paper towels and toilet paper rolls. Keep the restrooms organized and clean. Provide larger waste baskets in the restrooms to accomodate the used paper towels. The waste basket in the women's restroom is required to have a cover. Monitor and ensure that the restrooms are clean and supplied with soap and towels at all times.	11/02/2007
6-301.12	No single use hand towels are available for hand drying at the hand sink or in the women's restroom. Ensure that there are single use hand towels available at all hand sinks at all times. Mointor and refill immediatley when empty.	10/19/2007
4-501.11	The caulk on the sink in the women's restroom is coming apart. Re-caulk the sink to the wall and ensure that all gaps are sealed.	11/02/2007
	The handle at the urinal in the men's restroom is missing. Repair/replace the urinal handle to it's original form and function.	

### Inspection Notes

Notes: Keep three feet of clearance in front of the electrical panels in the back at all times. The product in the back room should be organized and should not block any egress from the premise. Provide an clear path so that one can walk from wall to wall without being obstructed by boxes and products.
