3-305.11	There are food boxes in the walk in cooler and freezer that are being stored on the floor. All food must be stored at least 6 inches off of the ground. Provide shelving and instruct all employees to store all food at least 6 inches off of the ground.	8/1/2008
3-306.11	Open food items are being stored on a buffet counter for self service. Provide approved sneeze guards for the open food items to prevent them from becoming contaminated.	8/1/2008
4-601.11	There is grease accumulation on the wall partition underneath the hood area. The wall must be cleaned as often as necessary to prevent any kind of grease buildup. Clean and maintain clean the wall.	8/15/2008
4-601.11	The interior plate of the ice machine on the East wall of the kitchen has a buildup of a grayish/black substance. The interior of the ice machine must be cleaned as often as necessary to prevent any growth or accumulation of mold and debris. Clean and maintain clean the ice machine.	8/1/2008
