





Re: Notice of Principal Expense Statement Discrepancies.

Dear Ms. Altenburg:

A review of the principal expense statement filed on behalf of Marquette University for the reporting period that began January 1, 2007, and ended June 30, 2007, has indicated the following:

1. A discrepancy in the amount of \$21.48. The amount of lobbying expenditures disclosed in Line 7 of the Principal Expense Statement (ccl-267d) is an amount less than the total amount disclosed in Column F of the Disclosure of Lobbying Activity form (ccl-267j).
2. Table 1 in Line 8 of the Principal Expense Statement understates by \$21.48 the lobbying expenditures made by the named lobbyists.

Because of the abovementioned discrepancies, the filing of an amended principal expense statement is required.


Please be advised that failure of the principal to file a completed principal expense statement and any required related forms within 10 days of receipt of this notice shall result in a suspension of lobbying privileges.


